In cases of gross negligence or intentional misconduct, the responsible party cannot be fully released from liability, even under this indemnification agreement.

17. Copyright Policy

The Digital Millennium Copyright Act (DMCA) of 1998 provides legal remedies for copyright owners who believe that online material infringes on their rights under U.S. copyright law. If you believe that your work has been copied in a way that constitutes copyright infringement, please provide our Copyright Agent with the following information:

- An electronic or physical signature of the person authorized to act on behalf of the copyright owner.
- Identification of the copyrighted work that you claim has been infringed.
- Identification of the location of the infringing material on the Site or Services, sufficiently detailed for us to locate the material.
- Information sufficient to contact you, such as your address, telephone number, and email address (if available).
- A statement from you, made in good faith, that the disputed use is not authorized by the copyright owner, its agent, or the law.
- A statement from you, made under penalty of perjury, that the information in your notice is accurate and that you are the copyright owner or authorized to act on behalf of the copyright owner.

18. Jurisdictional Issues

Fit at Home reserves the right to, at any time and at its sole discretion, restrict the availability and accessibility of the Site or Services for any person, geographic area, or jurisdiction as it sees fit and to limit the availability of certain services or products.

19. Termination

You agree that Fit at Home, at its sole discretion, may:

- Terminate your password, account (in whole or in part), or use of the Site or Services.

Consumer Rights Under EU Law

You and Fit at Home irrevocably agree to submit to the personal and exclusive jurisdiction of the courts of the Netherlands. You waive any objections related to jurisdiction, venue, or inconvenient forum in such courts.

21. Waiver and Severability

The failure to exercise or enforce any right or provision of these Terms and Conditions by Fit at Home shall not be considered a waiver of such right or provision.

If any provision of these Terms and Conditions is found to be unlawful, void, or unenforceable by a competent court, that provision shall be deemed severable from these Terms and Conditions and shall not affect the validity and enforceability of the remaining provisions.

Data Protection and GDPR Compliance

In the event of disputes concerning the processing of personal data, the General Data Protection Regulation (GDPR) shall apply.

22. Successors and Assignments

Fit at Home may perform all its obligations or exercise its rights under these Terms and Conditions through one or more of its affiliated businesses (including any entity that directly or indirectly controls, is controlled by, or is under common control with Fit at Home).

If Fit at Home or its assets are acquired by another entity, that entity will assume our rights and obligations as described in these Terms and Conditions, in compliance with applicable EU consumer law and the protection of your personal data under the GDPR.

Assignment Restrictions

You may not transfer or assign your rights or obligations under these Terms and Conditions, whether by law or otherwise, without prior written consent from Fit at Home, unless you are a consumer in the EU, where the law may grant you the right to transfer certain rights under specific circumstances.

23. Subscriptions, Free Trials, Payments, and Subscription Cancellations

1. Subscription

1. Ongoing Subscription

Your Fit at Home subscription, which may start with a free trial period, continues on a weekly, monthly, quarterly, semi-annual, or annual basis, depending on the subscription option you selected, and will automatically renew at each renewal period unless you cancel your subscription or we terminate it. To use the Fit at Home service, you must have internet access and provide us with a current, valid, and accepted payment method (which may be updated from time to time, the "Payment Method"). We will charge your Payment Method the subscription fee at the start of each renewal period (monthly, quarterly, annually, or as stated in the subscription term).
